IAM COVID-19 RESOURCE GUIDE

The following guide was created to provide IAM representatives useful resources to aid IAM members whose employment is adversely affected by COVID-19.

This guide focuses on securing unemployment insurance for workers who are laid off, or whose hours are reduced due to COVID-19.

Federal and state responses to the COVID-19 pandemic are changing rapidly and federal and state websites are being updated on a regular basis with new rules being implemented. The information contained in this guide was put together on March 20, 2020.

Representatives are encouraged to visit these websites often, so we can communicate the latest information to IAM members.

Federal and state guidelines/information regarding eligibility, the payment of unemployment benefits and COVID-19:

Federal guidelines issued:

- Unemployment Insurance Flexibilities
- NOTE: <u>Check with your state's unemployment insurance program</u> regarding the rules in your state.
- The Employment and Training Administration announced <u>new guidance</u> outlining state <u>flexibilities in administering their unemployment insurance programs to assist Americans</u> affected by the COVID-19 outbreak.
- Under the guidance, federal law permits significant flexibility for states to amend their laws to provide unemployment insurance benefits in multiple scenarios related to COVID-19. For example, federal law allows states to pay benefits where:

- An employer temporarily ceases operations due to COVID-19, preventing employees from coming to work; An individual is quarantined with the expectation of returning to work after the quarantine is over; and
- An individual leaves employment due to a risk of exposure or infection or to care for a family member.
- In addition, federal law does not require an employee to quit in order to receive benefits due to the impact of COVID-19.
